Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections for classes 1st to 12h shall be restricted to 22 only of which not more than 1/3rd of the total sections running may be used for Senior Secondary classes. The optimum number of the students shall be restricted to 40 for a classroom size of 500 sqr ft and above. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and availability of class rooms of 500 sq ft in dimension. The school is directed to run bal-vatika/foundation classes (I, II & III) in accordance with established norms permitted vide Board’s circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
2	The Biology lab and the Composite science labs seems to be under stocked and need to be upgraded with more stock and recommended safety measures like fire extinguishers, exhaust fans, safety manual for users. School is directed to follow the Board guidelines and the SoPs (circular no 11/2022) and upload the compliance with video link within 03 months on SARAS portal.
3	The Math lab has not been arranged properly with work stations and adequate seating arrangements. Small tables have been arranged along the walls in place of work stations as recommended as per the Board Guidelines and SoPs. School is directed to arrange and set up the lab properly with recommitted infartsructure and facilities and upload the compliance with video link within 03 months on SARAS portal.
4	The CwSN infrastructure also need to be upgraded as per circular no 11/2024 dated 09.08.2024. The ramp at the school entrance is without side handrails, CwSN toilets are seen separately at each floors. School is directed to arrange the CWSN infrastructure in compliance of Board directions and upload the compliance with video link within 03 months on SARAS portal.
5	School is directed to set up the Composite Skill lab in compliance of Board directions and guidelines notified vide circular no 75/2024 (No. CBSE/SE/JS/Skill Lab/2024) dated 23.08.2024 and upload the compliance with videography within 03 months on SARAS portal.
6	School is directed to ensure that all the essential vaild public documents are available under the head Mandatory Public Disclosure (as per appendix-IX) link on school's website at all the time and the link of certificates should remain functional and also to submit an undertaking in this regard on its letter head duly signed by the principal and the Manager of the school. The undertaking and compliance should be uploaded within 03 months on SARAS portal.
7	School shall ensure the mandatory training of its teachers from CoE, CBSE, Pune and shall upload the compliance on SARAS portal within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- The school shall renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
