Your date 13/8/2019 application context and then in this context is on the school /correspondence/school/verified/or on the basis of , I Education Officer (Pri.), Zilha Parishad, Thane Dt. 1/4/2019 to Dt. 31/3/2022 for a period of three years from Std.1st to Std. 8th for Indo - Scottish Global School , Ram Maruti Road , Thane (W). Dist. Thane school name with address) is giving temporary recognition to the school .

The above recognition is subject to the fulfillment of the following conditions .

1. The period of accreditation will not be extended and there will be no obligation under any circumstances to grant accreditation or affiliation after Class VIII .
2. Children to Free and Compulsory Education Act, 2009 (Annexure one) and Maharashtra children to free and compulsory education rights law in 2011 (Annexure two) in the provision , shall comply with the school .
3. School's will give admission to children's belonging to weaker sections and disadvantaged Sections near school in Std.1, uptill 25 % limit of student population and will sign and give them free and compulsory education till completion of Elementary education, but further that, to be in compliance also similar ratio case of pre-primary Classes.
4. For the children specified in paragraph three, the school will be provided with a separate bank account for reimbursement as per section 12 (2) of the Act .
5. Institutions / Schools will not recover any capitation fee and the methods of analysis for any child or his mother / Father (Parents) or Guardians will not be forced upon.
6. No child will be denied admission to school for reasons of religion, caste or ethnicity , place of birth or any of these for lack of proof of age .
7. (A) No child admitted to a school shall be detained in the same class in which he is or shall be expelled from the school till the completion of primary education .

(Two) for any child not be given to physical punishment or mental harassment .

(Three) will not be required to pass any board examination till completion of elementary education of any child . (Four) , each child completed primary education , rule 23 shall be determined in accordance with the certificate . (Six) under Section 23 (1) hold a minimum qualification prescribed under the case - will be appointed teachers . But even that , who do not hold the qualification date of commencement of the Act - or at least qualified teachers 5 will have to be acquired during the year .

(Seven) under Section 24(1) specifies that in his/empty themselves over the duties of a teacher and her

12. The school building or other construction or playground will be used only for educational and skill development purposes .
13. School Society Registration Act 1860 (1860 to 21) or the Bombay Public Trusts Act , 1950, is being run by the organization in accordance Register .
14. The school is not run for the benefit of any individual , group or individual or any other person or for any profit .
15. School accounts should be audited and certified by a chartered accountant and appropriate account statements should be prepared as per rules . A copy of each district return every year should be sent to the Education officer .

Operated by People's Education Society , English Medium School Thane (W) Dist . Thane school (English) Primary classes or through (Std. 1st to Std. 4th) on self help basis in 2013-14 academic year, the government has given approval to the school on the first subject to the following conditions prescribed .

1. The organization should be financially able to run the school on a self-supporting basis .
2. R.T.E, Act 2009 must be in accordance with the physical facilities .
3. According to the rules prescribed for the school, the prescribed age limit and trained teachers should be appointed and they should be paid salaries and allowances at the rate prescribed or approved by the government .
4. The Institution should strictly abide by this order issued by the Government from time to time, number of students in the class, admission of students, etc.
5. Separate toilets should be provided for boys and girls .
6. Parent Teacher Association , Mata Palak Sangh should be established and run as per rules .
7. The rates of fees should be fixed as per the decision of the government .
8. When appointing staff, teachers/ teaching staff should be appointed as per the roster.
9. The school building and premises should be conducive and safe for education .
10. The staff should be appointed subject to pay scales and conditions of service as prescribed by the Government from time to time .
11. The government schools / departments from time to time either - or command (eg . Student of joining and other items) must be strictly complied with .
12. The appointment of the headmaster will be subject to the approval of the concerned education inspector / education officer . The qualification of teachers will be as decided by the Government / Board from time to time .
13. New schools must use such letterheads on this self-help basis .
14. For the information of all concerned, it is necessary to indicate on the public board that the school has been sanctioned on a self-financed basis outside the school .
