

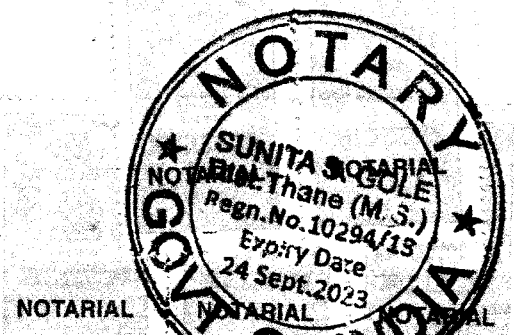

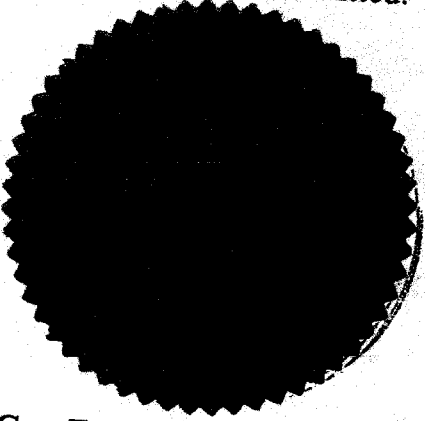

Operated by **People's Education Society , English Medium School, Ram Maruti Road, Ghantali Colony, Tal. Dist. Thane, Primary School (Std. 1st to Std. 8th) class through English on Self-Help Basis prescribed by the Government in the academic year 2013-14.** The above school is being recognized first subject to the following conditions.

1. The organization should be financially able to run the school on a self-supporting basis .
2. R.T.E, Act 2009 must be in accordance with the physical facilities .
3. According to the rules prescribed for the school, the prescribed age limit and trained teachers should be appointed and they should be paid salaries and allowances at the rate prescribed or approved by the government .
4. The Institution should strictly abide by this order issued by the Government from time to time, number of students in the class, admission of students, etc.
5. Separate toilets should be provided for boys and girls .
6. Parent Teacher Association , Mata Palak Sangh should be established and run as per rules .
7. The rates of fees should be fixed as per the decision of the government .
8. When appointing staff, teachers/ teaching staff should be appointed as per the roster.
9. The school building and premises should be conducive and safe for education .
10. The staff should be appointed subject to pay scales and conditions of service as prescribed by the Government from time to time .
11. The government schools / departments from time to time either - or command ( eg . Student of joining and other items ) must be strictly complied with .
12. The appointment of the headmaster will be subject to the approval of the concerned education officer .
13. The new school must use such letterhead on self-help basis while corresponding with the concerned authority by the organization accredited on this self-help basis.
14. For the information of all concerned, it is necessary to indicate on the public board that the school is allowed outside the school on the basis of self-help .

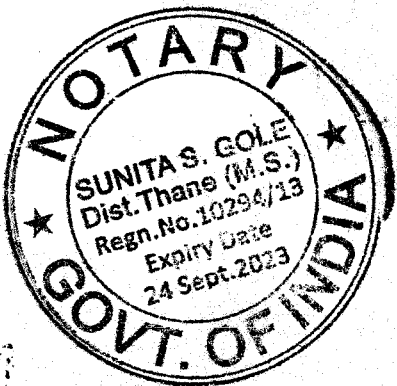


15. According to Government Resolution dated 09/02/2016, untrained teachers should not be appointed.
16. As per Government Resolution dated 14/07/2017, the first approval is being given in three years subject to bringing the school in A grade.
17. It is mandatory to strictly abide by all the provisions of the Right to Free and Compulsory Education Act, 2009 and the Maharashtra Self-Aided Schools (Establishment and Exchange) Act, 2012.
18. The terms and conditions of the Maharashtra Educational Institutions (Fees Regulation) Act, 2011 dated March 21, 2014 and the Maharashtra Educational Institutions (Fees Regulation) Rules, 2016 dated April 13, 2016 will be binding on the institution.
19. It is mandatory to keep school records and all kinds of records up to date.
20. Government prescribed by a mandatory data to be updated from time to time in the simplified system by you order.
21. It will be mandatory to take appropriate precautions, especially in the case of fire prevention, all arrangements for the health of the students and to take preventive precautions to prevent any accident due to fire.
22. As per Government Resolution dated 03.11.2009, Public Works Department of the Government or Dist. W. Must have a certificate from the Public Works Department Engineer that the school building is in accordance with the National Code (NCB).
23. As per the provisions under Section 4 (1) of the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012, the amount specified in Schedule C will have to be kept as a term deposit in a nationalized bank and a certificate of such deposit will have to be submitted.
